## **VILLAGE BOARD NEWS**

Mayor Lyle Fout called the meeting to order on July 7, 2025, at 6:30 P.M. at the Elkhart Village Hall. The meeting was opened with the Pledge of Allegiance. Roll call was taken. Answering present: Kyle Farmer, John Galassi, Matt Fights, Travis Moore, Matt Langan and Matt Olson. Clerk Mona Maas, Treasurer Amy Roberts, and attorney Don Behle were also present.

Motion by Travis Moore, second by Matt Fights, to approve Consent Agenda Items A, B, C, and D.

- B. Approve submitted bills and bill sheets
- C. Approve employee reimbursements
- D. Approve Treasurer's report

Roll call vote. All yeas. No nay. Motion carried.

## **STREETS/ALLEYS**

John Galassi questions if there is movement to resolve the situation of water in ditches on Kennedy Road; Lyle explained after lots of conversation with Logan County, review of maps and "history", the County has been out surveying, and he thinks it is moving forward. He does not know how soon but he will keep inquiring.

**PLEASE NOTE: July 17 & 18, the county will begin sealcoating.** They begin on Gillette Street at Gov. Oglesby and will go south of town, around to "near" Cornland. We need to be sure to **move cars off the road for those two days**, so they don't get oil on them, and to give the crews room to work.

## **VILLAGE PARK**

- The Village installed the new aeration system; system is up and running.
- Travis Moore and Matt Fights have both been working to clear areas to make the pond more accessible on the banks. Conversation on what Village equipment might be used to improve access points off the steeper banks.
- Discussion on need for shed, protection for equipment, improvements. Ideas shared and discussed.
- Travis Moore initiated discussion on picnic table(s); There are some \$\$ left in Ameren grant from 11/24 for a table. Travis will do some research on possible sturdy table for the pond site.

## **NEW BUSINESS**

- a. Lyle and Kyle Farmer will meet with the Route 66 organization to hear more about the plans for the 100-year anniversary of Route 66 in 2026.
- b. Pike Creek Wind Farm. Contract with extension reviewed; meeting with Lyle and Repsol Renewables (tentatively) scheduled this week.
- c. The soda machine outside the Village Hall has died. Discussion on whether to replace with new one, repair, etc. The Village will get a different machine.

- d. Research on Ameren's Right Tree, Right Place annual grant continues. Tree Advisory Committee moving forward on application.
- e. Kyle Farmer initiated discussion of who is responsible for the Coal Mine Road; Lyle has had many discussions with different parties but will look into organizing some more details and report back.
- f. General discussion on Elkhart properties that are unoccupied and deteriorating; if they were to be "torn down", freeing up the space, there is confidence that Veteran's or "Habitat for Humanity" home(s) could be built and that would be a plus for Elkhart.
