

WHAT MAKES ELKHART UNIQUE AND SPECIAL?

Elkhart is unique and special for many reasons - one, but not the only one, is the people who live and have lived in our little corner of the earth. We would like to introduce you to some of them.

James Latham

James Latham is considered the "founding father" of what will eventually become known as our town of Elkhart. James was born in Virginia in 1786, but his family moved to Union County, Kentucky, when he was a young boy. He eventually married Mary Briggs, and they had ten children. In 1818, Illinois officially became a state; and word of its very fertile soil began to spread and lure those with an adventurous spirit to come westward and settle here. James's two oldest children, Richard and his sister Elizabeth along with her husband James Chapman, decided to check it out in the fall of 1818. Soon James decided to come join them. They first staked out a claim near the Sangamon River (just south of the present current town of Sherman) but heavy snows produced a very muddy thaw in January, 1819. They soon decided to move farther north toward a higher mound of land.

The higher ground or "Hill" was known as Elkhart Grove, and after scouting around, they found the best location was on the northern slope with "fresh spring water". By April they had built the first cabin north of the Sangamon River and proceeded to plant 30 acres of corn. They expanded their "settlement" and built a double cabin. After that was accomplished, James returned back to Kentucky to bring his wife and other 8 children back to this wonderful spot in September, 1819, in what would eventually become known as Elkhart in Logan County, Illinois.

Besides planting the first corn crop here, James Latham accomplished quite a few other firsts. He and his son Richard built the first horse mill (took four horses to run it) in the area. When he finally got around to filing his land claim in 1824, he received over 620 acres (which is now Elkhart township). He was also appointed that same year by President John Quincy Adams as Indian Agent at Fort Clark (where Peoria is currently located). He moved there for two years, where he got sick and died in 1826. His remains were brought back to Elkhart Grove and buried close to where his first cabin was built, which is currently known as Latham Cemetery (the oldest cemetery in Logan County). His wife Mary lived until 1887, and she is also buried there.
