ORDINANCE AMENDING THE LIQUOR ORDINANCE

TO ALLOW ADDITIONAL SUNDAY HOURS

THE VILLAGE OF ELKHART, LOGAN COUNTY, ILLINOIS

WHEREAS, the Mayor and Board of Trustees of the Village of Elkhart, Logan County, Illinois(the “village”) has heretofore adopted Ordinance No. 01-07 on the 9<sup>th</sup> day of May, 2001, for the purpose of establishing a system of local control of the sale of alcoholic liquor; and

WHEREAS, said ordinance does not allow Sunday sales of alcoholic liquor; and

WHEREAS, the Mayor and Board of Trustees desire to set Sunday liquor sales hours.

**NOW, THEREFORE, BE IT ORDAINED** by the Mayor and Board of Trustees of the Village of Elkhart, Logan County, Illinois, as follows:

**Section 1:** That the Preambles hereto are true and correct and are incorporated herein by reference as if fully set forth at this point.

**Section 2:** That Section 16 (A) 2. CONDITIONS OF LICENSE: Closing Hours; of Ordinance No. 01-07 “ AN ORDINANCE PERTAINING TO LIQUOR CONTROL” is amended to read as follows:

2. Class T Licenses

It shall be unlawful for the holder of a Class T license issued under this ordinance, to sell or offer for sale at retail any alcoholic liquor in the village:

On Sunday, after the hour of 1:00 a. m. until 11:00a.m. and from 11:00p.m. until midnight;

On Monday through Thursday, between the hours of midnight and 5:00 a.m.;

On Friday, between the hours of Midnight and 5:00 a.m.;

On Saturday, between the hours of 1:00a.m. and 5:00 a.m.

A Class T licensee shall not admit any customers after the hour at which time the sale of alcoholic liquor is required by this section to be terminated, and shall cause all customers to vacate the licensed premises within one-half hour after the time at which sales of alcoholic liquor are required by this section to be terminated, and shall not permit the consumption of alcoholic liquor by any person on the licensed premises after the time customers are required to vacate and before the time the licensee may next commence sales under this Section.

**Section 3:** That all other provisions of Ordinance 2001-07 are hereby ratified and confirmed without change except as set forth in this Ordinance.

**Section 4:** That all other Ordinances, Resolutions and Enactments of the Village in conflict herewith are hereby expressly repealed to the extent of said conflict.

**Section 5:** That this Ordinance shall be effective upon its passage, signing and publication as required by law.
