New Business: 2025 Energy Transition Community Grant- Use of Funds. The Village has received a grant award of \$50,805.85. The Village recommends using the funds for planning, engineering, design, and construction of a new water well and replacement of water lines. Public comment is sought on the use of these funds for this purpose or any other potential uses. Letter of support from Lincoln Land Community College was submitted. *For those who were unable to make this meeting, there are still ways to share your thoughts and ideas. Also, a portion of Logan County's Energy Transition Community Grant can be earmarked to help fund a plan to more effectively drain the water off the ditches on Kennedy Road. *The public was notified of this opportunity to attend to comment.*
